

Tenure-Track / Practice-Track Faculty Positions Busch School of Business

The Busch School of Business at The Catholic University of America seeks candidates to fill **four** full-time faculty positions (both tenure-track and practice-track) to begin in August 2024.

The Catholic University of America is the national university of the Catholic Church with 6,000 undergraduate and graduate students in more than 180 academic programs on a residential campus in the heart of the nation's capital. The Tim and Steph Busch School of Business, founded in 2013, is committed to the application of Catholic Social Doctrine to business through thought leadership and the formation of students as virtuous Catholic business leaders. The Busch School is housed in Maloney Hall, a beautiful century-old collegiate gothic building that reopened in early 2019 after a \$37 million renovation.

We seek candidates who understand, are enthusiastic about, and will make a significant contribution to the mission of the University, which reads as follows:

As the national university of the Catholic Church in the United States, founded and sponsored by the bishops of the country with the approval of the Holy See, The Catholic University of America is committed to being a comprehensive Catholic and American institution of higher learning, faithful to the teachings of Jesus Christ as handed on by the Church. Dedicated to advancing the dialogue between faith and reason, The Catholic University of America seeks to discover and impart the truth through excellence in teaching and research, all in service to the Church, the nation and the world.

The Busch School is hiring in several areas, including:

- Strategic Management (focused on but not limited to Business Strategy, Operations, International Business, or Business Analytics);
- Marketing and Sales (focused on growing the school's nationally-recognized Sales program);
- Finance (to serve as the Area Head of our swiftly growing finance area); and
- Political Economy (areas of competence open; interest in industrial organization and corporate strategy a benefit).

Candidates for both tenure-track and practice positions are welcome to apply. Candidates are preferred at the rank of assistant professor, but candidates at other ranks will also be considered. Candidates should have a passion for the School's mission, a relevant and rigorous research agenda (for tenure-track candidates), and a strong commitment to excellence in teaching. Ideal candidates in strategic management and political economy will have doctoral degrees and robust research programs. Ideal candidates in Sales and Finance will have ample industry experience and a passion for scaling fast-growing programs.

Responsibilities include: academic research (tenure-track candidates), teaching at the undergraduate and graduate level, mentoring students, and service to the department, school, University, and the profession.

For full consideration, applications should be received by February 16, 2024. The application should include:

- a letter of interest clearly articulating your areas of teaching, research and professional expertise, and the academic area within the Busch School to which you are applying;
- CV;
- three references; and
- a personal mission statement indicating how your teaching, service, and prior experience will make a distinctive contribution to the life of our School, our University's mission, and the vision of Catholic education outlined in the <u>Apostolic Constitution on Catholic Universities</u>, <u>Ex Corde Ecclesiae</u>.
 - Note: This element is critical to the application. It will be reviewed at both the School and Provost-level.
