



**Assistant Professor of Practice, Elementary or Secondary Teacher Education
Liu Taylor Endowed Chair
Department of Education, School of Arts and Sciences**

The Department of Education of the School of Arts and Sciences of The Catholic University of America seeks to fill an Endowed Chair for an Assistant Professor of Practice position in Elementary or Secondary Teacher Education, to begin on August 20, 2024. The appointment is a non-tenure track position with an emphasis on teaching and service. Professor of Practice faculty may also participate in research or other scholarly endeavors.

The Liu Taylor Endowed Chair will have recognized distinction as a teacher-scholar and academic administrator; potential and willingness to provide leadership to their colleges and departments in terms of the University's educational, scholarly, and service missions; high levels of collegiality and professionalism; compatibility with the particular academic specifications established by the donor of the chair; and compatibility with and ability to contribute to the Catholic University of America's (CUA) Catholic values and mission.

The Liu Taylor Endowed Chair's primary responsibility will be to serve as the Coordinator of the Elementary or the Secondary Education Program. Program Coordinators are responsible for managing curricula, course sequencing, and periodic review of key assessments for program learning outcomes. In collaboration with the Director of Student Experience and Licensure (DOSEL), Program Coordinators also assist in the drafting and submission of internal and external reporting for accreditation for CAEP, OSSE, and other SPAs. Additional duties may also include teaching, advising students, and supervision for Elementary or Secondary teacher education candidates during their student teaching internship. They also are expected to attend faculty meetings, School of A&S faculty meetings, and other school events.

The Liu Taylor Endowed Chair will also support the Department of Education's Catholic identity renewal initiative with CUA's Institute for the Transformation of Catholic Education (ITCE). Alongside the Department's rich history of pedagogical excellence as recognized by CAEP, the Department will engage in a multi-year strategic planning curricular review to renew Catholic Identity in education, research and leadership in the Department of Education.

Qualifications:

- Doctoral degree (Ed.D. or Ph.D.) in Teacher Education, Educational Leadership, or related field;
- Significant teaching and administrative experience in grades K-12;
- Reading Specialist experience preferred;
- Familiar with curriculum development, iteration, sequencing, and implementation;
- Teacher mentor/coaching experience preferred.
