Assistant/Associate Clinical Professor & Associate Dean for Master's Programs

The Conway School of Nursing (CSON) at The Catholic University of America (CUA) seeks to fill an 8.5-month, benefits-eligible Assistant/Associate Clinical Professor. The incumbent would also serve in the administrative role as Associate Dean for Master's Programs to begin Fall 2022.

The CSON is distinguished for preparing expert clinicians, nurse scientists, and leaders. The CSON is CCNE accredited and has over 500 students enrolled in BSN, MSN, DNP, and PhD programs. Ranked #6 by U.S. News and World Report, the on-line Master's Programs prepare family nurse practitioners (FNPs), adult-gerontological nurse practitioners (AGNPs), and acute and primary care pediatric nurse practitioners (PNPs). Post-graduate APRN certificate program tracks are also available and in January 2023 an Acute Care Adult-Gerontology Nurse Practitioner program will also be initiated. The on-line DNP program, approved for post-master's and post-baccalaureate pathways, focuses on leadership in advanced nursing practice. The on-line PhD program prepares expert clinicians as nurse scientists.

3. Eligibility for tuition exchange for children who want to pursue an undergraduate degree at another university or college other than CUA
4. Participation in an exceptional retirement plan (TIAA). If the faculty member contributes 5%, CUA will contribute 10% of gross salary.
5. One day per week for clinical practice.

Responsibilities:

As faculty:

1. Reports to the Dean and Directs the Adult Gerontological Nurse Practitioner Program and oversees the faculty directors of the other nurse practitioner programs.
2. Collaborates with the placement coordinator and NP Program Directors in identifying and vetting preceptors and clinical sites.
3. Teaches distance graduate students online. Teaches distance and on-campus doctoral students. Teaches graduate students on-campus in clinical laboratory and simulation settings 1-2 times per academic year.
4. Develops written syllabi and all course materials; evaluates knowledge of subject matter taught, prepares and grades exams; and monitors students' academic achievement
5. Utilizes course materials effectively, demonstrating thorough knowledge of content
6. Maintains academic standards and course expectations throughout each courses
7. Maintains and enhances knowledge of subject matter taught and individual training skills required to remain current with new trends and developments in nursing
8. Implements nontraditional and innovative methods of instruction to foster critical thinking
9. Uses effective interpersonal, leadership, and organizational skills to teach in the curriculum
10. Participates in student advisement and academic counseling
11. For any student not performing successfully, provides feedback and develops and individualized remediation plan
12. Contributes to the ongoing development of the AGNP nurse practitioner program and doctoral program through course revisions and refinements and implementation of formative and summative evaluation processes
13. Participates in development, implementation, and evaluation of objectives and goals for the nurse practitioner programs
14. Participates in CSON and university committees and activities

Qualifications:

1. Earned doctoral degree PhD/DNP, certification as an Adult Gerontological Nurse Practitioner (AGNP).
2. Eligible for a Washington D.C. advanced practice license
3. Nationally board certified as a nurse practitioner (Adult Gerontological Nurse Practitioner)
4. Three to five years graduate and doctoral teaching experience in a nurse practitioner program / doctoral program.
5. Proficiency using online learning platforms, clinical coordination software, and learning management systems.
6. Excellent communication and organizational skills
7. Able to work collaboratively and productively with colleagues

- Two letters of recommendation
- A one- to two-page personal statement indicating how your research, teaching, and service will make a distinctive contribution to our University's mission and to the vision of Catholic education outlined in the Apostolic Constitution on Catholic Universities *Ex Corde Ecclesiae*.
